- 1. New members having a current, verifiable VSGA/USGA handicap index will begin the Tour with that index. It will be part of your handicap until you have played your 4th tournament, after which only your RVSGT tournament rounds will be used to compute your Tour handicap.
- 2. In the absence of a VSGA/USGA handicap index, a new member may provide information on their 2 lowest scores from 10 recent rounds, from which your initial handicap will be established. A stroke control provision will apply for your first 4 rounds limiting your net score. See *Handicap Info* on our website for specifics. If you fail to provide this information, your initial handicap will be "0". The Tour may adjust your handicap at any time if your Tour play is inconsistent with your submitted rounds.
- 3. If you are unable to compete in an event, you must notify Joe Bass not later than 3 days prior to the event. IMPORTANT If you DO NOT participate in a tournament, you WILL NOT automatically be entered in the next tournament, and you must notify Joe Bass at least 3 days prior to have your "IN" play status reinstated. Late withdrawals and No Shows may be liable for the full tournament fee.
- 4. In submitting this application, <u>you agree to fully abide by the RVSGT & USGA Rules of Golf during tournament play</u>. Failure to adhere to these rules may result in penalties, disqualification, or suspension from the Roanoke Valley Senior Golf Tour.
